## NOTIFICATION

New Delhi, the 9th December, 2020

**No. DE-22(16)-2020.**—In exercise of the powers conferred by Section 20 of the Dentists Act, 1948, the Dental Council of India, with the previous approval of the Central Government, hereby makes the following Amendment to the existing principal "Dental Council of India (Establishment of New Dental Colleges, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity in Dental Colleges) Regulations, 2006", published in Part III, Section 4 of the Gazette of India, Extraordinary, dated 12<sup>th</sup> January, 2006 namely:-

1. **Short title and commencement:-**

- (i) These Regulations may be called the "Dental Council of India (Establishment of New Dental Colleges, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity in Dental Colleges) (16<sup>th</sup> Amendment) Regulations, 2020".
- (ii) They shall come into force with effect from the date of their publication in the official Gazette and shall be applicable only for the academic year 2020-21.
